The Willem C. Vis International Commercial Arbitration Moot is the largest and most renowned moot competition in international commercial law and arbitration.

The Paris Bar School gives you the opportunity to participate in this competition in a team of four selected students, against about 400 university teams from all over the world.

The selected team will represent the parties in a fictional arbitration case concerning the UN Convention on Contracts for the International Sale of Goods (CISG).



## **PARTICIPATING IN THE VIS MOOT**

During the written phase, the team will analyze the case file and will draft memoranda for both the claimant and the respondent.

In the oral phase, the team will prepare pleadings and present its arguments in front of experienced practitioners in Paris and abroad.

In Vienna, over 2500 students from over 80 jurisdictions will compete for the awards: a great opportunity to meet your future peers in international arbitration!
